

We can help you talk to other places.




# We can help you

That is OK.




# Before the meeting

It may say


- who makes the choices

Bring your papers to our office.


We are in South Central Commercial.

We read the copy **before** the meeting.




We give your papers back.

## At the meeting




You talk to a lawyer.

We tell you the rules.


They are for the person who makes your


